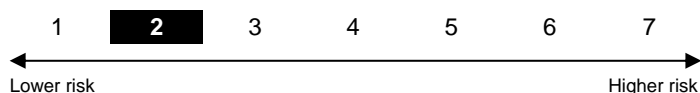
Objectives:

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?
